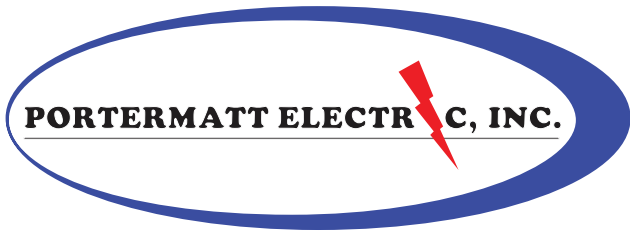

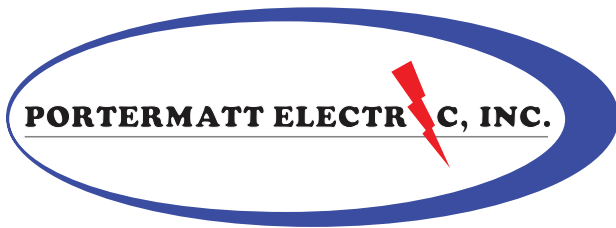

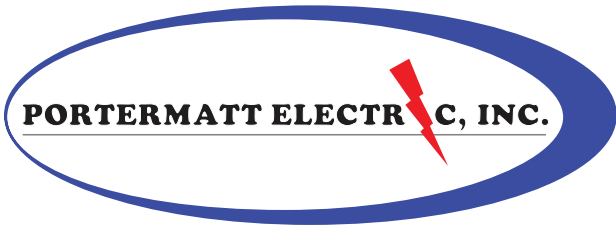

PorterMatt Electric is based out of Huntington Beach, CA and primarily works in California, but we are licensed in six states, and we periodically work in all six.

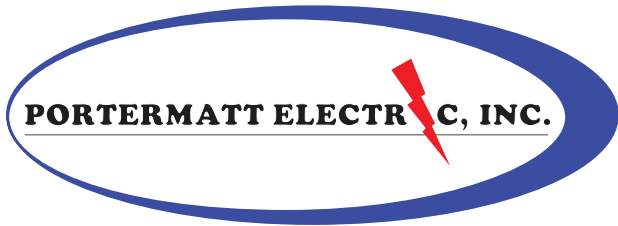

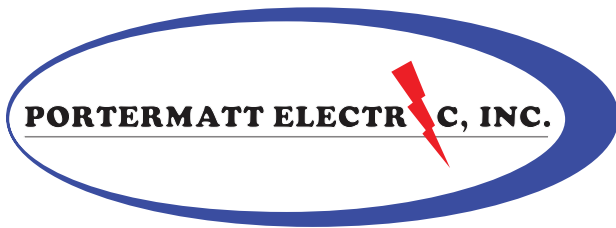
